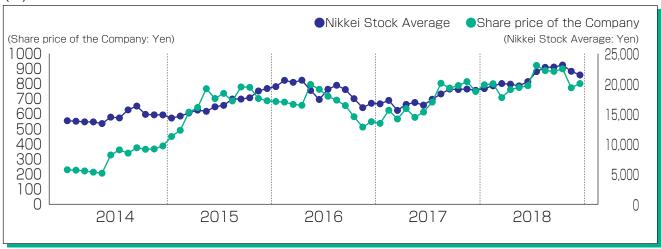

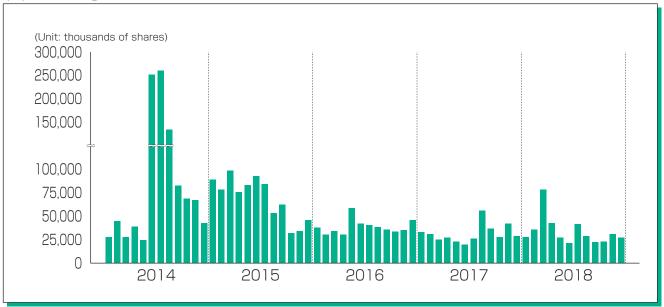

(3) Trading Volume



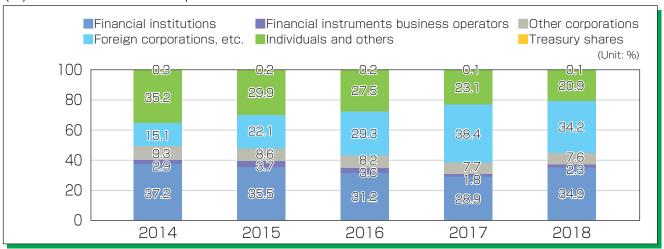
